

- o The recognized research supervisor shall be permitted to guide only in the discipline approved. In case of interdisciplinary research, it will be considered based on the merits of research expertise.
- o A research supervisor should have a minimum of three years of service before the date of superannuation while a candidate is registering under the research supervisor.
- o If, for any reason, the research supervisor takes voluntary retirement from service or leaves the service or moves away from the jurisdiction of the University, his/her guideship shall stand cancelled. However, such research supervisor shall be permitted to complete their commitments to the students already registered.
- o As per the existing regulations, an Assistant Professor can accommodate upto a maximum of one (1) M.Phil and four (4) Ph.D., scholars at any given point of time.
- o This recognition of guideship shall be governed by the Regulations 2016 of the Madurai Kamaraj University and shall also be subject to amendments, if any, from time to time.
